## **REVENUE SUPPORT GRANT SPECIFIED BODIES 2024-25**

### **Purpose**

- 1 To agree the top slice arrangements for 2024-25.

### **Background**

- 2 In 2024-25 Welsh local government is due to provide top slice funding from the Revenue Support Grant to the Specified Bodies detailed below, to support their activities in the next financial year. At Appendix 1 is a schedule of Specified Bodies funding in 2023-24 and the principles to be applied to uplifting funding in 2024-25. The Specified Bodies are:

- The National Eisteddfod
- Royal Welsh Agricultural Show
- Urdd Eisteddfod
- Foster Wales
- National Adoption Service
- The WLGA

### **Approach to top slicing the Revenue Support Grant**

#### **National Cultural Events**

- 3 The Chief Executive has been in discussions with these organisations and has ascertained the need for continued funding in the next financial year. The increase for the funding for 2024-25 will be held flat.

## Social Services

- 4 The National Adoption Service (NAS) is a collaboration for the provision of adoption services across Wales and promotes and supports best practice in adoption on an all-Wales basis. The work undertaken as part of the National Fostering Framework (NFF) led to the launch of Foster Wales (FW) in 2021.
- 5 A review of the funding model for the National Adoption Service and Foster Wales was undertaken over the past few months and a detailed report is on the agenda to be considered by members, with a number of recommendations on how this is better managed moving forward.
- 6 It is proposed that the top slice funding for both bodies be held flat in 2024-25, pending the outcome of other discussions. There is a variance to the proposed level of topslice, as set out in the NAS/FW funding review, and it is proposed £53k is removed from the topslice for 2024/5 (and recovering the payment included in the topslice for 2023/4 as this is currently funded through the Welsh Government grant) but this will need to be included in future requests when the Welsh Government grant comes to an end.
- 7 Funding has been secured from the Welsh Government for NAS and FW to enable them to take forward their significant pieces of work, many of which are Programme for Government commitments.

## WLGA Retained Top Slice

- 8 As referred to in the section on budget principles, the WLGA retained top slice is to be held flat in 2024-25. This funding is used to support Data Cymru, the Food in Schools team, Employment & Workforce advice from the LGA, funding for Directors of Public Protection, the Office of the Chief Digital Officer and supports various initiatives within the WLGA.
